On January 22, 2009, the Wisconsin Board of Nursing considered the petitioner's request for modifications to the Board order dated October 4, 2007, to decrease his therapy requirement, decrease his drug screens and to allow him access to administered controlled substances in his workplace. Based upon the information presented showing that the petitioner has a therapist letter of support for some of the modifications, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modifications to the limited license of JAMES LARSON, R.N., (lic. #115740) are GRANTED.

IT IS FURTHER ORDERED that the petitioner's therapy requirement shall be decreased at the discretion of his health care provider and that the petitioner shall be allowed access to administer controlled substances in his workplace.

IT IS FURTHER ORDERED that the petitioner's drug screens shall NOT be reduced because he has been granted access to administered controlled substances.
