ORDER GRANTING DECREASE IN DRUG SCREENS AND DENYING TERMINATION OF THERAPY

On November 5, 2009, the Wisconsin Board of Nursing considered the petitioner's request for modifications to the Board order dated October 4, 2007, to terminate his therapy requirement and decrease the frequency of his drug screens. Based upon the information presented showing that the petitioner does not have a therapist letter of support for termination of therapy but is in compliance with the remaining terms and conditions of his order, the Board now finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that request for decrease in the frequency of drug screens for JAMES LARSON, R.N., (lic. # 115740) is GRANTED. The Petitioner's screens shall be reduced to twenty-eight (28) per year with one (1) annual hair test.

IT IS FURTHER ORDERED that the petitioner's therapy requirement shall not be terminated unless Petitioner obtains a letter from his therapist supporting termination.
