On April 15, 2009, the Wisconsin Medical Examining Board considered the petitioner's request for modifications to the Final Decision and Order dated October 17, 2007, to reduce the therapy requirement, eliminate AA/NA attendance, remove the restriction on personal use of alcohol and terminate the requirement that all prescriptions of controlled substances issued by the petitioner must be reviewed with 24 hours. The information of record shows that petitioner has had two positive drug screens for controlled substances without a legitimate prescription, and that the length of time that he has been in compliance with the order does not warrant modifications, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modifications to the limited license of MICHAEL S. MOORE, M.D. (lic.#20-4138) are hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall submit a written explanation for his recent positive screens on December 19 and 23, 2008, for consideration by the Board at its next meeting.
