The Dentistry Examining Board considered this matter at its meeting on May 6, 2009.

### **BACKGROUND**

On February 4, 2009, Dr. Anderson submitted a request to the Board to modify the terms of its Final Decision and Order, dated January 9, 2008, by reducing his random urine drug and alcohol screens. The Board considered Dr. Anderson's request at its May 6, 2009 meeting. Based upon all the information of record, the Board orders the following:

### **ORDER**

**NOW, THEREFORE, IT IS ORDERED** that Dr. Anderson's request to modify the number of random urine drug and alcohol screens, as described in paragraphs C.12-C.18 of the Board's January 9, 2008 Final Decision and Order be, and hereby is, Denied.

**IT IS FURTHER ORDERED** that Dr. Anderson shall provide valid prescriptions for the positive drug screens received on 01/05/09, 01/16/09, 03/13/09, 03/16/09 and 04/17/09 within two (2) weeks of the date of this Order.
