On May 7, 2009, the Board of Nursing considered the petitioner's request for modification of the board order dated February 28, 2008, to discontinue her therapy, reduce her drug screens and allow her to work as a registered nurse with her current employer, a nurse pool agency. Based upon the information presented which shows that the petitioner has been in compliance with the order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modifications to the limitations upon the license of JUDI L. OLSON, R.N. (#94686-30) is GRANTED. Petitioner's therapy requirement is discontinued and petitioner's drug screens are reduced to forty-two (42) per year.

IT IS FURTHER ORDERED that the petitioner is approved for a single work site with her existing agency employer provided that her work schedule not exceed forty-five (45) hours per week.
