On February 19, 2009, the Real Estate Board filed its Final Decision and Order in the above-captioned matter by which the board ordered that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding be assessed against respondents. Pursuant to sec. RL 2.18 (4), Wis. Admin. Code, on or about February 20, 2009, the Real Estate Board received the Affidavit of Costs in the amount of \$1,701.52, filed by Attorney Mark A. Herman. On or about March 2, 2009, the Real Estate Board received the Affidavit of Costs of the Office of Legal Counsel in the amount of \$457.50, filed by Administrative Law Judge Colleen M. Baird. The Real Estate Board considered the Affidavits of Costs on April 30, 2009, and orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding in the amount of \$2,159.02, set forth in the Affidavits of Costs of Attorney Mark A. Herman and Administrative Law Judge Colleen M. Baird, which are attached hereto and made a part hereof, are hereby assessed against respondents, and shall be payable by respondents to the Department of Regulation and Licensing. Each respondent is assessed fifty percent of the total costs, in the amount of \$1,079.51. Failure of respondents to make payment on or before May 30, 2009, shall constitute a violation of the Order unless respondents petition for and the board grants a different deadline. Under sec. 440.22 (3), Wis. Stats., the Department of Regulation and Licensing may not restore, renew or otherwise issue any credential to the respondent until respondent has made payment to the department in the full amount assessed.
