On November 3, 2008, the Barbering and Cosmetology Examining Board filed its Final Decision and Order in the above-captioned matter by which the board ordered that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding be assessed against respondents. Pursuant to sec. RL 2.18 (4), Wis. Admin. Code, on or about November 4, 2008, the Barbering and Cosmetology Examining Board received the Affidavit of Costs in the amount of \$1,707.63, filed by Attorney Claudia Miran. On or about November 5, 2008, the Barbering and Cosmetology Examining Board received the Affidavit of Costs of the Office of Legal Counsel in the amount of \$305.00, filed by Administrative Law Judge Jacquelynn B. Rothstein. The Barbering and Cosmetology Examining Board considered the Affidavits of Costs on February 2, 2009, and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding in the amount of \$2,012.63, set forth in the affidavits of costs of Attorney Claudia Miran and Administrative Law Judge Jacquelynn B. Rothstein, which are attached hereto and made a part hereof, are hereby assessed against respondents, and shall be payable by respondents to the Department of Regulation and Licensing. **Failure of respondents to make payment on or before March 4, 2009, shall constitute a violation of the Order unless respondents petition for and the board grants a different deadline.** Under sec. 440.22 (3), Wis. Stats., the Department of Regulation and Licensing may not restore, renew or otherwise issue any credential to the respondents until respondents have made payment to the department in the full amount assessed.
