BACKGROUND

At its March 26, 2009, meeting the Wisconsin Chiropractic Examining Board (Board) reviewed the information presented to it by the Department of Regulation and Licensing's Monitor regarding the Respondent's compliance with the Board's August 14, 2008, Order.

On August 14, 2008, the Board issued a Final Decision and Order for the Respondent. The Order required the Respondent to complete 6 hours of preapproved continuing education (CE) in record-keeping for Chiropractors within 180 days of the date of the order. The 180 days ended on February 10, 2009.

FINDINGS OF FACT

1. The Respondent submitted a CE program for Board approval on February 2, 2009. The Respondent did not submit any other program for the Board's consideration.
2. The program does not meet the requirement in the August 14, 2008, Order that he take 6 hours of CE in record-keeping for Chiropractors.
3. The Respondent did not complete 6 hours of pre-approved CE in record-keeping prior to February 10, 2009.
4. The Respondent made efforts toward completing his CE requirement.

ORDER

THEREFORE IT IS HEREBY ORDERED THAT, Dr. Ruzga is granted a 90 day extension to complete the CE requirement in his August 14, 2008, Order. The extension begins on March 26, 2009.

IT IS FURTHER ORDERED THAT this Order is effective on March 26, 2009.
