On March 6, 2009, the Department of Regulation and Licensing filed its Final Decision and Order in the above-captioned matter by which the department ordered that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding be assessed against respondent. Pursuant to sec. RL 2.18 (4), Wis. Admin. Code, on or about March 16, 2009, the Department of Regulation and Licensing received the Affidavits of Costs in the amount of \$932.05, filed by Attorney John R. Zweg. On or about March 13, 2009, the Department of Regulation and Licensing received the Affidavits of Costs of the Office of Legal Counsel in the amount of \$371.08, filed by Administrative Law Judges Ruby Jefferson-Moore and Nick Schweitzer. The Department of Regulation and Licensing considered the Affidavits of Costs on April 16, 2009, and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding in the amount of \$1,303.13, set forth in the Affidavits of Costs of Attorney John R. Zweg and Administrative Law Judges Ruby Jefferson-Moore and Nick Schweitzer, which are attached hereto and made a part hereof, are hereby assessed against respondent, and shall be payable by respondent to the Department of Regulation and Licensing. **Failure of respondent to make payment on or before May 16, 2009, shall constitute a violation of the Order unless respondent petitions for and the department grants a different deadline.** Under sec. 440.22 (3), Wis. Stats., the Department of Regulation and Licensing may not restore, renew or otherwise issue any credential to the respondent until respondent has made payment to the department in the full amount assessed.
