On January 22, 2009, the Wisconsin Board of Nursing considered the petitioner's request for an initial stay of suspension, pursuant to modifications to the Board Order dated October 2, 2008. In addition, the petitioner requested an installment payment plan for the costs assessed under the Board Order. Based upon the information presented showing that the petitioner is not eligible for a stay under the terms of order which suspended his license for a period of six (6) months, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for an initial stay of suspension of the registered nurse license of DAVID P. CROSS, R.N., (lic. # 146614) is DENIED.

IT IS FURTHER ORDERED that the petitioner may repay the costs under an installment payment plan; in the amount of \$25.00 per month until such time as a stay is granted.
