#### PROCEDURAL HISTORY

The Real Estate Examining Board (Board) issued an Order dated October 30, 2008, requiring Frank J. Rondon (Petitioner) to pay a forfeiture of \$1,000.00 by April 30, 2009, and costs of \$1,000.00 by October 31, 2009. On April 17, 2009, the Petitioner asked the Board to extend the time for payment of the forfeiture to July 31, 2009. On June 25, 2009, the Board granted that extension. On July 14, 2009, the Petitioner submitted another petition asking the Board to extend the time for payment of the forfeiture to October 31, 2009. On August 20, 2009, the Wisconsin Real Estate Board (Board) reviewed the July 14<sup>th</sup> petition.

### FINDINGS OF FACT

The Petitioner requested an extension of time because of the economic downturn and the resultant housing slump.

# **ORDER**

THEREFORE, THE BOARD ORDERS THAT, Frank J. Rondon's request for an extension of time is granted with the following conditions:

- 1. Frank J. Rondon must pay \$500.00 of the forfeiture to the Department Monitor on or before September 30, 2009. The Department Monitor shall suspend his license if he fails to timely make the payment. The Monitor shall reinstate his license upon receipt of payment in full of the forfeiture and costs.
- 2. Frank J. Rondon must pay \$1,500.00 for the remainder of the forfeiture and for costs by December 31, 2009. The Department Monitor shall suspend his license if he fails to timely make the payment. The Monitor shall reinstate his license upon receipt of payment in full of the forfeiture and costs.
- 3. The Board will not issue any additional extensions.

This Order takes effect on the date of signing.
