On February 26, 2009, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order dated December 4, 2008, which granted her a limited registered nurse license. The petitioner is now seeking approval of a drug testing program in Minnesota in lieu of enrolling with the board-approved First Lab program. Based upon the information presented, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that request for a modification to the limited license of TRACY J. MANTHEY, R.N., is GRANTED to allow her to continue drug testing through the Minnesota Health Professional Service program. IT IS FURTHER ORDERED that the petitioner shall be required to obtain board pre-approval of any worksite in Wisconsin and, if such worksite is approved, the petitioner shall be required to enroll in the First Lab Program for her drug screens prior to commencing employment as a nurse in Wisconsin.
