ORDER FIXING COSTS

On July 13, 2009, the Hearing and Speech Examining Board filed its Final Decision and Order in the above-captioned matter by which the board ordered that pursuant to sec. 440.22, Wis. Stats., two-thirds of the costs of this proceeding be assessed against respondent. Pursuant to sec. RL 2.18 (4), Wis. Admin. Code, on or about July 17, 2009, the Hearing and Speech Examining Board received the Affidavit of Costs in the amount of \$4,427.20, filed by Attorney Sandra L. Nowack. On or about July 24, 2009, the Hearing and Speech Examining Board received the Affidavit of Costs of the Office of Legal Counsel in the amount of \$579.50, filed by Administrative Law Judge John N. Schweitzer. The Hearing and Speech Examining Board considered the Affidavits of Costs on October 5, 2009, and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., two-thirds of the costs of this proceeding in the amount of \$4,271.74, set forth in the Affidavits of Costs of Attorney Sandra L. Nowack and Administrative Law Judge John N. Schweitzer, which are attached hereto and made a part hereof, are hereby assessed against respondent, and shall be payable by respondent to the Department of Regulation and Licensing. **Failure of respondent to make payment on or before November 4, 2009, shall constitute a violation of the Order unless respondent petitions for and the board grants a different deadline.** Under sec. 440.22 (3), Wis. Stats., the Department of Regulation and Licensing may not restore, renew or otherwise issue any credential to the respondent until respondent has made payment to the department in the full amount assessed.
