PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Respondent Lori A. Deschner is licensed in the State of Wisconsin as a Barbering or Cosmetology Practitioner, license # 82-43308. This license was first granted to her on 10/13/1981 and is current through 03/31/2009. The most recent address on file with the Department of Regulation and Licensing for Ms. Deschner is 909 Racine Street, Delavan, WI 53115.
- 2. On June 6, 2005, the Barbering and Cosmetology Examining Board disciplined Lori A. Deschner in Division of Enforcement Case No. 04 BAC 009 for failing to employ a manager of record for approximately two years at Panache (barbering and cosmetology establishment #80-21237, located at 828 E. Geneva Street, Delevan, WI), failing to change Barbacide solution daily, failing to post a copy of the Blood Exposure Protocol in the salon, and failing to submit an application to the Department for a new establishment license after her salon had moved to a different location at 1428 E. Geneva Street, Delevan, WI.
- 3. The investigation in the present case revealed that Ms. Deschner failed to employ a full-time manager for Panache (license # 80-32303), located at 1428 E. Geneva Street, Delevan, WI, from approximately January 2005 until she sold the salon in April 2006, and failed to notify the Department when Panache was no longer operating without a manager of record. During that time, Ms. Deschner was the owner of Panache and was therefore responsible for employing a full-time

manager for the salon.

4. The investigation in the present case revealed further that the establishment license for Panache (# 80-32303) expired on 06/30/2005, and the salon remained in operation under Ms. Deschner's ownership until Ms. Deschner sold the salon in April 2006. Ms. Deschner's explanation for this is that she erroneously renewed the license for her prior salon, also called Panache, instead of the license for the new Panache. Department records show that the establishment license for Panache (# 80-21237), located at 828 E. Geneva Street, Delevan, WI, the establishment Ms. Deschner owned prior to Panache (#80-32303) located at 1428 E. Geneva Street, Delevan, WI, was renewed in July 2005. It does appear that Ms. Deschner renewed the wrong establishment license.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
 - 2. Respondent Lori A. Deschner has violated:
 - a. Wis. Stat. § 454.08(6) and Wis. Admin. Code §§ BC 2.06(5) and BC 3.02(1) by failing to employ a full-time manager for Panache at 1428 E. Geneva Street, Delevan, WI, for approximately fifteen months, from January 2005 to April 2006; and
 - b. Wis. Stat. by failing to renew the correct establishment license for the new location of Panache
- 3. This is Ms. Deschner's second violation of Wis. Stat. § 454.08(6) and Wis. Admin. Code §§ BC 2.06(5) and BC 3.02(1) for failing to employ a manager at Panache.
 - 4. As a result, Deschner is subject to discipline pursuant to Wis. Stat. § 454.15(2)(i).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The practitioner's license of Lori A. Deschner (license # 82-43308) is hereby SUSPENDED for 10 working days, beginning 10 working days from the date of this Order.

IT IS FURTHER ORDERED that:

- 2. Respondent shall pay a FORFEITURE in the amount of SEVEN HUNDRED FIFTY DOLLARS (\$750.00) and shall pay COSTS in the amount of SEVEN HUNDRED FIFTY DOLLARS (\$750.00).
- 3. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

4. Payment of the forfeiture and costs, which total FIFTEEN HUNDRED DOLLARS (\$1,500.00), shall be made according to the following schedule:

- 5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may, in the alternative, impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fail to timely submit any payment as ordered, then the Respondent's license (#82-43308) SHALL BE SUSPENDED without further notice or hearing until Respondent has complied with the terms of this Order.
 - 6. This Order is effective on the date of its signing.
