PROCEDURAL HISTORY

The parties in this matter agree to the terms of the attached Stipulation as the final decision of this matter, subject to the approval of the Department Secretary. The Department Secretary has reviewed this Stipulation and considers it acceptable.

The Department Secretary adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

- 1. Dale R. Brenon ("Respondent"), date of birth 07/06/53, is licensed as private detective having license #63 009819. This license was first granted on 08/19/96.
- 2. The last reported address on file with the Department of Regulation and Licensing ("Department") for the Respondent is: 13412 Ballentine Street, Overland Park, Kansas 66213.
- 3. On or about July 10, 2006, Department records indicate the Respondent submitted an online renewal application to the Department for renewal of his private security person credential. The Respondent answered "NO" to the question of: "Have y been convicted within the past two years of a felony, misdemeanor or a violation of any state or local law (other than traffic) tha punishable by a forfeiture, or, are charges pending? (If yes, provide information.)"
- 4. A routine Criminal Information Bureau (C.I.B.) background check was conducted of the Respondent's application by the Department's credentialing division. The C.I.B. background check revealed a 2005 misdemeanor charge was pending against the Respondent. Based on the results of the C.I.B. background check on the Respondent's application, a case was opened for investigation.
- 5. On October 31, 2006, the Respondent reported to the Department that he had been found guilty of the misdemeanor charges pending against him.

- 6. The Department's investigation revealed that the Respondent made a material misrepresentation on his renewal application to the Department when he answered "NO" to the question concerning whether or not he had been "convicted within the past two years of a felony, misdemeanor or violation of any state or local law…"
- 7. In resolution of this matter, the Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Department of Regulation and Licensing has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.21.
- 2. The Department of Regulation and Licensing is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44 (5).
- 3. Respondent, Dale R. Brenon has violated:

Wis. Stat. §§ 440.26 (6)(a) 3.4. and Wis. Admin. Code §§ RL 35.01 (17)(18) by providing false information to the Department on his renewal application regarding whether or not criminal pending charges existed against him

ORDER

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

- 1. The attached Stipulation is herby accepted.
- 2. Respondent, Dale R. Brenon, license #63 9819, be, and hereby is, REPRIMANDED.
- 3. Respondent Dale R. Brenon, shall, within 60 days of the date of this Order, pay COSTS of this matter in the amount of TWO HUNDRED FIFTY DOLLARS (\$250.00).

IT IS FURTHER ORDERED, that in the event that Dale R. Brenon fails to timely submit payment of the costs as set forth above, the private security permit for Dale R. Brenon (# 63 9819) **SHALL BE SUSPENDED**, without further hearing and without further Order of the Department, and said suspension shall continue until the full amount of said costs has been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Department.

IT IS FURTHER ORDERED, that file 06 RAL 081, be and hereby is, closed as to Respondent, Dale R. Brenon.
