PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Respondent **Harlows Off Main** is licensed in the State of Wisconsin as a barbering or cosmetology establishment, having license # 80-30145. This license was first granted to it on 11/28/01. The most recent address on file with the Department of Regulation and Licensing for this establishment is 327 South Street, Waukesha, WI 53186.
- 2. The Department received a complaint that Harlows Off Main was operating with an expired establishment license.
- 3. The Department's investigation revealed that Harlows Off Main was operating with an expired establishment license for approximately four months, from July 1, 2007 to October 31, 2007.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. Respondent **Harlows Off Main** has violated Wis. Stat. § 454.08(1)(b), Wis. Admin. Code §§ BC 2.04(1) and 3.01 by operating with an expired establishment license. As a result, Harlows Off Main is subject to discipline pursuant to Wis. Stat. § 454.15(2)(i).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. **Harlows Off Main** (license # 80-30145) be, and hereby is, REPRIMANDED.

IT IS FURTHER ORDERED that:

- 2. **Harlows Off Main** shall, within 120 days of the date of this Order, pay **COSTS** in the amount of **THREE HUNDRED FORTY DOLLARS (\$ 340.00).**
- 3. **Harlows Off Main** shall, within 180 days of the date of this Order pay a **FORFEITURE** in the amount of **TWO HUNDRED DOLLARS (\$200.00)**.
- 4. Payment of the costs and forfeiture shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

- 5. In the event Respondent fails to timely submit any payment as ordered, then the Respondent's license (#80-30145) SHALL BE SUSPENDED without further notice or hearing until Respondent has complied with the terms of this Order.
