FINDINGS OF FACT

1. Exquisite Threading plans to operate out of a kiosk in Southridge Mall in Greendale, Wisconsin. The owners submitted information to the Board indicating how they plan to meet establishment sanitation standards
2. The kiosk will have a self-contained water unit for sanitation purposes. Water would have to be replenished, and the dirty water gotten rid of, at a location in the mall away from the kiosk. The system described contains a 5 gallon clean water tank and a 5 gallon dirty water tank. One 5 gallon clean water gallon tank is sufficient to supply clean water for more than two practitioners.

CONCLUSIONS OF LAW

NOW, THEREFORE, IT IS ORDERED that Exquisite Threading is granted a Barber and Cosmetology Establishment License subject to the following limitations:

ORDER

1. Exquisite Threading may provide threading as a service, but may not provide any other barber and cosmetology service or any related services.
2. No more than 2 employees may practice in the establishment at a time.
3. The kiosk must remain in the same location in the mall.
