**PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Barbering and Cosmetology Examining Board. This matter comes before the Board after the issuance of a formal complaint.

The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

**FINDINGS OF FACT**

1. Bonnie L. Anderson, (DOB 8/27/1953) is duly licensed as an electrologist in the State of Wisconsin (license # 84-751). This license was first granted on 2/7/1997.
2. The most recent address on file with the Department of Regulation and Licensing (“Department”) for Respondent Anderson is 102 North Elms Street, Wittenberg, WI 54499.
3. Lasting Image Electrolysis, 140 South Main Street, Shawano, WI 54166, was licensed as an electrology establishment in the State of Wisconsin (license # 70-570). This license was first granted on 11/18/1999 and expired on July 10, 2007. Respondent Anderson was the owner of Lasting Image Electrolysis.
4. As a licensee, Respondent Anderson was and is at all times relevant to this action responsible for compliance with Wisconsin Statutes, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapters 2 and 3.
5. On or about July 15, 2005, the Department received a consumer complaint alleging Respondent Anderson was operating an unlicensed electrology establishment, Lasting Image Electrolysis. At the time the Department received the consumer complaint, Lasting Image Electrolysis’ license was in expired status. Subsequently, a case was opened for investigation.
6. On July 8, 2003, Respondent Anderson submitted renewal fees and applications for herself, Lasting Image Electrolysis

and Wittenberg Electrolysis (#70-594; granted: 09/29/00; current). At the time Respondent Anderson submitted these renewals, all three licenses were in expired status.

7. On July 10, 2003, the Department Renewal Office sent Respondent Anderson a \$25 late fee notice for each of the three credentials.
8. On September 4, 2003, the Renewal Office sent Respondent Anderson second late fee notices.
9. Respondent Anderson never paid the late fees.
10. On November 14, 2003, Respondent Anderson was issued a refund of the application fees for all three credentials.
11. On August 5, 2005, Respondent Anderson renewed all three credentials.
12. On March 15, 2006, an inspection of Lasting Image Electrolysis was conducted by a Department investigator. Respondent Anderson was not present at the inspection. The inspection revealed that Respondent Anderson practiced electrology without a current electrologist license and Lasting Image Electrolysis had operated without an electrology establishment license during the period of July 8, 2003 through August 4, 2005.
13. In resolution of this matter, Respondent Bonnie L. Anderson consents to the entry of the following Conclusions of Law and Order.

### **CONCLUSIONS OF LAW**

1. The Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15.
2. The Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
3. Respondent, Bonnie L. Anderson has violated:  
  
Wis. Stat. 454.04(1)(a) and Wis. Admin. Code § BC 2.04(1) by providing electrology services with an expired license during the period of July 8, 2003 through August 4, 2005; and  
  
Wis. Stat. 454.08(1)(b) and Wis. Admin. Code §§ BC 2.045(1); 3.01(1) and 3.02(3) by operating an electrology establishment (Lasting Image Electrolysis) with an expired license during the period of July 8, 2003 through August 4, 2005.

### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the license of Bonnie L. Anderson (#751-84) is REPRIMANDED.

IT IS ALSO ORDERED that Respondent Bonnie L. Anderson shall jointly and severally pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND DOLLARS (\$1,000.00).

IT IS FURTHER ORDERED that the Respondent shall jointly and severally pay costs in the amount of EIGHT HUNDRED DOLLARS (\$800.00).

Three payments of SIX HUNDRED DOLLARS (\$600.00) shall be paid. The first payment of SIX HUNDRED DOLLARS (\$600.00) will begin on July 1, 2009 and continue every ninety (90) days until the full ONE THOUSAND EIGHT HUNDRED DOLLARS (\$1,800.00) is paid. Payment shall be made **by certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing, and mailed to:

**Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to submit timely any payment of the forfeiture as set forth above, or fail to pay costs as ordered, Respondent Anderson's license (#751-84) and the establishment license of Lasting Image Electrolysis (license #570-70) SHALL BE SUSPENDED, without further notice or hearing until Respondents have complied with the terms of this Order.**
