On November 5, 2009, the Wisconsin Board of Nursing considered the petitioner's request for modifications to the order of the Board dated July 23, 2009, as she is having difficulty obtaining employment as a nurse. Based upon the information presented showing that the petitioner is in compliance with the terms and conditions of the order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request by the petitioner, JUDITH A. MUELLER, R.N. (lic. # 54444) for modifications is GRANTED. The petitioner's screens shall be decreased to fourteen (14) per year plus one (1) annual hair test until such time that the Petitioner obtains employment as a nurse. Upon employment, the screens shall be increased to twenty-eight (28) per year plus one (1) annual hair test.

Petitioner shall not be released from her Board order until she has worked as a nurse under the terms and conditions of the order for the full five (5) years.
