PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Barbering and Cosmetology Board (Board). The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Caitlin Stublaski (Respondent) (DOB 4/14/1983) is duly licensed as a barbering and cosmetology practitioner in the state of Wisconsin (license # 88443-82). This license was first granted on May 12, 2008, and is current through March 31, 2011. The license was is expired status from April 1, 2009, to April 19, 2009.
- 2. Respondent's most recent address on file with the Department of Regulation and Licensing (Department) is 2102 North Oakland Avenue, Milwaukee, WI 53202
- 3. Respondent completed the Barbering and Cosmetology program at The Institute of Beauty and Wellness in April 2005.
- 4. Shortly after Respondent completed her schooling, she was hired to provide barbering and cosmetology services at Neroli Salon & Spa (Neroli).
- 5. Respondent in fact provided barbering and cosmetology services at Neroli from 2005 through early 2007, during which time she did not possess a valid barbering and cosmetology practitioner license.
- 6. Respondent did not apply to take the examination for the barbering and cosmetology practitioner license until December 14, 2007, when she was granted her temporary permit to practice.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stats. § 227.44 (5).

- 2. The conduct described in paragraph 5. of the Findings of Facts above constitutes a violation of Wis. Stat. § .454.04 (1) (a).
- 3. Wis. Stat. § 454.15 (2) (i) provides that the Board may discipline a licensee who has violated chapter 454 or any rule promulgated under chapter 454.
- 4. Because Respondent violated Wis. Stat. § 454.04 (1) (a), she is subject to discipline by the Board.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED:

- 1. The license of Caitlin Stublaski (license #88443-82) to practice barbering and cosmetology in the state of Wisconsin is hereby REPRIMANDED.
- 2. Respondent shall, within 180 days from the date of this order, pay a forfeiture of ONE THOUSAND DOLLARS (\$1,000.00) and the costs of this proceeding in the amount of TWO HUNDRED dollars (\$200.00), for a total of ONE THOUSAND TWO HUNDRED (\$1,200.00) dollars. Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:

- 3. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to submit timely any payment of the forfeiture as set forth above, or fails to pay costs as ordered, or fails to comply with the ordered continuing education, Respondent's license (#88443-82) SHALL BE SUSPENDED, without further notice or hearing until Respondent has complied with the terms of this Order.
- 4. This Order is effective on the date of its signing.
