**PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

**FINDINGS OF FACT**

1. Monica L. Ceisel, whose date of birth is November 8, 1974, is duly licensed as a barbering or cosmetology manager in the state of Wisconsin (license #81-29639). This license was first granted on September 25, 2003, and is current through March 31, 2011. The last address Ms. Ceisel reported to the Department of Regulation and Licensing (Department) is 3623 Hickory Ridge Road, Oshkosh, Wisconsin 54904.
2. Ms. Ceisel was also licensed as a barbering or cosmetology practitioner in the state of Wisconsin, from January 3, 1996, to June 30, 2005.
3. On June 4, 2008, Departmental Investigator Douglas Austin inspected 3623 Hickory Ridge Road in Oshkosh, Wisconsin. The Department had received a complaint that Ms. Ceisel was running an unlicensed barbering and cosmetology business out of her home.
4. Ms. Ceisel admitted to Investigator Austin that a portion of the house was set up as a salon, and admitted that she had been performing barbering or cosmetology services for compensation for approximately a year and a half. Ms. Ceisel did not have a barbering or cosmetology establishment license for the salon in her home at the time of the inspection.
5. A barbering or cosmetology establishment license for Ms. Ceisel’s salon in her home (Studio 3623 Total Image) was granted by the Department on June 10, 2008 (license #80-36000).

6. In resolution of this matter, Monica L. Ceisel consents to the entry of the following Conclusion of Law and Order.

**CONCLUSIONS OF LAW**

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15.

2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached stipulation pursuant to Wis. Stat. § 227.44 (5).

3. By the conduct referred to in Findings of Fact 4., Monica L. Ceisel has violated Wis. Stat. §§ 454.08(1)(b) and Wisconsin Administrative Code §§ BC 2.04(1), BC 2.045, and BC 3.01(1), and is subject to discipline pursuant to Wis. Stat. § 454.15(2)(i).

**ORDER**

1. **NOW, THEREFORE, IT IS HEREBY ORDERED** that the barbering or cosmetology manager license of Monica L. Ceisel (license # 81-29639) shall be REPRIMANDED.

2. IT IS FURTHER ORDERED that Monica L. Ceisel shall pay to the Department of Regulation and Licensing a forfeiture in the amount of ONE THOUSAND DOLLARS (\$1,000.00).

3. IT IS FURTHER ORDERED that Monica L. Ceisel shall pay to the Department of Regulation and Licensing total costs in the amount of THREE HUNDRED SEVENTY-FIVE DOLLARS (\$375.00).

4. Payment of the costs and forfeiture, which total ONE THOUSAND THREE HUNDRED SEVENTY-FIVE DOLLARS (\$1,375.00) shall be made according to the following schedule:

5. In the event Ms. Ceisel fails to timely submit any payment as ordered, then her license (# 81-29639) SHALL BE SUSPENDED without further notice or hearing or board action until she has complied with the terms of this Order.
