On February 26, 2009, the Wisconsin Board of Nursing considered the petitioner's request for approval of the continuing education courses taken to fulfill the requirements of the Final Decision and Order dated September 17, 1998, and for approval to take a board-approved nurse refresher course. Based upon the information presented which shows that the petitioner has fulfilled the continuing education requirements, the Board now finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for approval of the continuing education courses completed by JANINA M. KENNEBECK, L.P.N. (lic. # 32990-31) is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner is hereby approved for a limited license for the sole purpose of completing a board-approved nurse refresher course. Upon verification that she has successfully completed the refresher course, the petitioner shall be eligible to petition for re-registration of her nursing license.
