PROCEDURAL HISTORY

The Wisconsin Chiropractic Examining Board (Board) issued an Order dated March 26, 2002, that revoked Richard Golde's (Petitioner) license to practice chiropractic medicine in Wisconsin. On September 17, 2009, Petitioner, through his attorney Raymond M. Roder, petitioned the Board to reinstate his license. At its meeting on October 8, 2009, the Board reviewed the Petitioner's case.

FINDINGS OF FACT

1. The Petitioner testified before the Board concerning his past and the treatment he has undergone. He also talked about how he feels about his past actions, how he has worked to gain self awareness and what he has done to improve his interactions with people.
2. The Petitioner's psychologist Dr. James M. Peterson, Ph. D., appeared by phone and responded to questioning by the Board about the Petitioner's current health. He testified that he believes that the Petitioner has made great strides in therapy regarding his anger management problems but that continued therapy is needed.
3. Dr. Peterson stated that he believes it would be helpful for the Petitioner to practice in a group setting.
4. Dr. Peterson stated that the Petitioner is more aware of his past failings in dealing with personal relationships and that he is trying to avoid those previous problems. Dr. Peterson stated that he does not know of any problems that have occurred since he has been working with the Petitioner. He also stated that he believed that it was Richard Golde's intent to remain in therapy with him.
5. In a written report Dr. Peterson submitted to the Board he indicated that Richard Golde self-referred himself and was first seen in an intake session on January 29, 2008. Richard Golde indicated that it was his intent to seek a psychological evaluation and whatever treatment might be indicated based upon the evaluation to become fit to practice chiropractic. He provided Dr. Peterson with documentation of his history. Dr. Peterson thought that the documentation appeared to be fully forthcoming.
6. Dr. Peterson was aware of Richard Golde's history with the Board and knew of the circumstances underlying the revocation of his license.

CONCLUSION OF LAW

The Board has jurisdiction over this matter pursuant to ss. 440.035 and 446.02, Wis. Stats.

ORDER

IT IS HEREBY ORDERED THAT, Richard Golde will be granted a limited license when he has provided evidence to the Department Monitor that he has met all of the following requirements:

1. Complete the National Board of Chiropractic Examiners SPEC examination with a passing score.
2. Complete the Wisconsin Jurisprudence examination with a passing score.
3. Complete 40 credit hours of continuing education approved by the Board. None of these credits may be used toward the continuing education credits required for renewal of a license.
4. Complete 4 hours of continuing education credit in each of the topics of boundaries, ethics, and radiology for a total of 12 hours. These classes may be taken through programs offered for chiropractors and for other health care professionals. These courses must be submitted to the Department Monitor for approval prior to taking the courses. None of these credits may be used toward the continuing education credits required for renewal of a license and are in addition to the hours required in # 3 above.
5. Obtain current certification in AED and CPR.

IT IS ALSO ORDERED THAT, when the Department Monitor grants Richard Golde a license it will contain the following limitations:

1. Richard Golde may only work as an associate in a clinic approved by the Board.
2. Richard Golde if required to have a board approved chiropractor within the clinic who will act as his supervisor within the clinic. Richard Golde shall provide the Supervisor with copies of all Orders concerning himself.
3. The supervising chiropractor will have to file with the Department Monitor, performance reports about Richard Golde, monthly for the first three months and quarterly thereafter. The reports must include an assessment of Richard Golde's competence regarding patient care, documentation, interaction with patients and co-workers and confrontational situations. The supervisor shall report any adverse incidents to the Department Monitor immediately.
4. The Board reserves the right to require Richard Golde to obtain an independent mentor.
5. Another chiropractor must be present in the clinic at all times Richard Golde is in the clinic.
6. Richard Golde may not treat any patient in any location other than in the clinic approved by the Board.
7. Richard Golde may not have any involvement in the business or billing practices of the clinic.
8. Richard Golde may only have professional relationships with clinic staff.
9. Richard Golde must continue to meet not less than once per month with Dr. Peterson or another psychologist who has been approved by the Board. The treating psychologist shall submit quarterly reports to the Department Monitor regarding the progress of Richard Golde's treatment. The psychologist shall report to the Department Monitor immediately if he or she notes any indication of any negative change in Richard Golde's behavior.
10. Richard Golde may not petition the Board to modify the terms of this Order for a period of not less than two years from the date the limited license is issued.

11. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in the summary suspension of Richard Golde's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order.
