PROCEDURAL HISTORY

A disciplinary proceeding was commenced in this matter by the filing of a Notice of Hearing and Complaint with the Board on July 18, 2007. Prior to the hearing on the Complaint, the parties in this matter agreed to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Respondent is Azam Mohammed Bhatti, M.D., dob 3/15/58, who is licensed as a physician and surgeon in Wisconsin pursuant to license #43562, first granted on 7/19/01. Respondent's address of record is 3260 N. Pilgrim Rd., Brookfield, WI 53005; he practices at AMB Clinic, 10625 W. North Ave., #100, Wauwatosa, WI 53226. Respondent is a sole practitioner and is listed in the Board's records as practicing occupational medicine. He is not certified by any board approved by the American Board of Medical Specialties, and is not licensed in any other state.
- 2. A formal Complaint has been filed in this matter. Respondent, a dual citizen of the United States and Pakistan, is presently living and working in Pakistan, and has no immediate plans to return to the United States. Solely to settle this matter, and without admitting any of the allegations of the Complaint, Respondent agrees to surrender his Wisconsin license.
- 3. Respondent may petition the Board for reinstatement at any time that he desires to resume the practice of medicine in the United States, subject to the terms and conditions of this Order. Any such petition shall state all of the activities in which Respondent has engaged from the date of this Order to the date of the Petition, including a statement concerning the extent to which he has practiced medicine, his continuing medical education credits earned, and any other information which the Board may deem appropriate to determine whether Respondent is, at that time, able to practice medicine with skill and safety to patient and public.

4. If the Board does grant Respondent's Petition, the license shall initially be subject to the same restrictions as are set forth in the Board's Interim Order of June 20, 2007, and the formal Complaint now pending shall be reinstated to its present procedural posture, without prejudice to either side. If Respondent is ultimately found to have committed unprofessional conduct or negligence in treatment with respect to the allegations of the Complaint on file in this matter, he may be required to pay all costs of the investigation and prosecution of this matter, both those incurred to date, and any incurred after the filing of any Petition for reinstatement.

CONCLUSIONS OF LAW

A. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is accepted.

IT IS FURTHER ORDERED, that the SURRENDER of the license to practice medicine of Azam M. Bhatti, M.D., is ACCEPTED. Respondent shall not practice medicine in Wisconsin without being properly licensed and registered.

IT IS FURTHER ORDERED, that the COSTS of investigating and prosecuting this matter are \$10,200 as of the date of this Order. If Respondent is ultimately found to have committed unprofessional conduct or negligence in treatment with respect to the allegations of the Complaint on file in this matter, he may be required to pay all costs of the investigation and prosecution of

this matter, both those incurred to date, and any incurred after the filing of any Petition for reinstatement.
