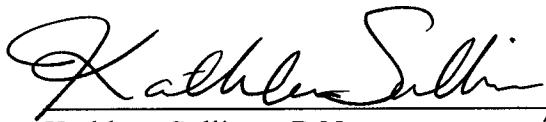
On October 14, 2010, the Wisconsin Board of Nursing considered the petitioner's request for a stay of suspension pursuant to the Final Decision and Order of the Board dated May 19, 2000. The petitioner also requested a limited license to complete a nurse refresher course since she has failed to renew her registered nurse license within five years of its renewal date. Based upon the information of record which shows that petitioner has not been in compliance with the terms and conditions of the order due to her failure to participate in an approved drug testing program, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a stay of suspension for the license of ANN M. SCHUCK, (# 107349-30) to practice as a registered nurse in the state of Wisconsin is DENIED.

IT IS FURTHER ORDERED that petitioner's request for a limited license for the sole purpose of completing a nurse refresher course is DENIED.
