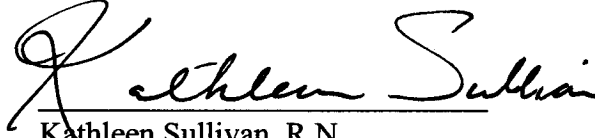
ORDER

NOW, THEREFORE, IT IS ORDERED that the request access to controlled substances for patient administration in the workplace license for JANICE S. RIESE, R.N. (lic. #125307-30) is hereby GRANTED.

IT IS FURTHER ORDERED that petitioner's random urine drug screens shall be decreased to forty-eight (48) per year plus one (1) additional hair test, in accordance with the Board's current testing schedule.
