On July 22, 2010, the Board of Nursing considered the petitioner's request for a stay of suspension pursuant to the Board's Final Decision and Order dated May 3, 2001. The information presented shows that petitioner has violated the terms and conditions of the order and is ineligible for a stay of suspension. Accordingly, the Board now finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a stay of suspension of the license of Paul Lauer, (lic. #106610) to practice as a registered nurse in the state of Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall submit a letter from a health care provider which verifies his fitness to practice and upon submission of evidence satisfactory to warrant the reinstatement of his license, petitioner be required to enter into the current standard five (5) year impairment order.
