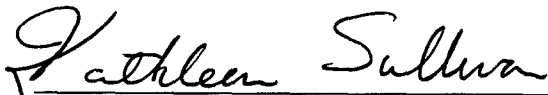
On October 14, 2010, the Wisconsin Board of Nursing reconsidered the petitioner's request for modification to the order of the Board dated January 27, 2005, to terminate her therapy requirement. Based upon the information presented which shows that the petitioner does not have support for termination of therapy from her therapist and due to concerns expressed in a work report related to petitioner's nursing practice, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modification of the Board order to terminate the therapy requirement for the registered nurse license of ANITA JONES, R.N. (lic. # 126154-30) is hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall enroll in the Affinity Health Systems drug testing program for her drug screens immediately.
