PROCEDURAL HISTORY

The Barbering and Cosmetology Examining Board (Board) issued an Order dated April 3, 2006, ordering Plaza Barber Stylists and Johnny Santiago (Respondents, collectively), jointly and severally, to pay costs in the amount of \$700.00 and a forfeiture in the amount of \$2,000.00. The Order called for installment payments pursuant to a specified schedule. Due to nonpayment, a violation of the Order, the Respondents' licenses were suspended on October 9, 2007. By letter dated November 9, 2007, Respondents asked the Board to reinstate the licenses and extend the time for payment of costs and forfeitures. On December 11, 2007, the Board ordered the licenses would be reinstated if Respondents began \$100 payments by January 16, 2008. Respondents failed to make any payment and the licenses were not reinstated. By letter dated February 1, 2010, Respondents requested a modification of the Order to adjust, reduce, or settle the amount of the forfeiture. The Board denied the request by Order dated February 12, 2010. By letter dated March 1, 2010, Respondents requested a reinstatement of license and a payment plan of \$100 per month. The Board considered this request at its May 3, 2010 meeting.

FINDINGS OF FACT

- 1. The April 3, 2006 Order provided that all payments and submissions required by the Order be mailed or delivered to the Department Monitor, Division of Enforcement, Department of Regulation and Licensing, P.O. Box 8935, Madison, WI 53708-8935.
- 2. According to the records and information presented by the Division of Enforcement Department Monitor, the Respondents have never made any payments towards the costs and forfeitures as Ordered.
- 3. The Respondents' request for modification of the Board's Order should be denied based upon the Respondents' failure to comply with the terms and conditions of the said Board's Orders.

CONCLUSIONS OF LAW

- 1. The Board has jurisdiction to act in this matter pursuant to Wis. Stats. s. 454.15.
- 2. The Respondents have violated the Board's Order by not paying the costs and forfeitures as ordered.

THEREFORE IT IS HEREBY ORDERED that the Respondents' request for Modification is DENIED.
