On May 6, 2010, the Wisconsin Board of Nursing considered the petitioner's request for reinstatement of her Advance Practice Nurse Prescriber (APNP) certificate to enable her to resume practice as a certified registered nurse anesthetist (CRNA). Based upon the petitioner's current mental health and AODA assessment, petitioner is deemed capable of resuming her CRNA practice with reasonable skill and safety. Accordingly, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request of JULIE A. WILCOX, for reinstatement of her Advance Practice Nurse Prescriber certificate ((lic. # 623-33) is hereby GRANTED with a STAY OF SUSPENSION and LIMITATIONS.

IT IS FURTHER ORDERED that petitioner shall be permitted to resume practice as a CRNA subject to the following LIMITATIONS:

- 1. Petitioner shall submit to random drug screens by a pre-approved drug testing program at the frequency of forty-eight (48) per year plus five (5) annual hair tests.
- 2. Petitioner shall personally perform the daily telephone check-in with the drug testing program to determine if she is selected for a drug screen. This process shall not be performed by petitioner's family members or any other person on her behalf.
- 3. Petitioner shall maintain all mental health and AODA treatment as required under her original Board order dated March 9, 2006.

- 3. Petitioner shall maintain all mental health and AODA treatment as required under her original Board order dated March 9, 2006.
- 4. Petitioner may not work "on-call" or accept any unscheduled work duties or assignments in her CRNA practice.
- 5. Petitioner's disposal or "wasting" of anesthesia drugs in her CRNA practice must be supervised by another licensed health care provider and documented by the employer.
- 6. Petitioner is prohibited from requesting any modifications of the limitations set forth herein for a period of one (1) year.
