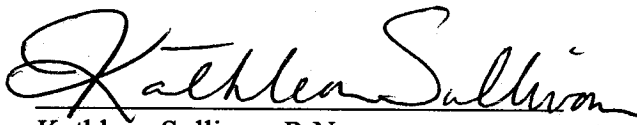
On September 2, 2010, the Wisconsin Board of Nursing considered the petitioner's request for modification to the limitations on her Advanced Practice Nurse Prescriber (APNP) certificate. Specifically, petitioner seeks a modification to allow her to take "on-call" rotations as a certified registered nurse anesthetist (CRNA). Based upon the insufficient length of time that petitioner has been in compliance with Board's order which only recently reinstated her advanced practice credential, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modification of the limitations on the Advanced Practice Nurse Prescriber certificate (# 623-33) of JULIE A. WILCOX, is hereby DENIED.

IT IS FURTHER REITERATED that petitioner shall not request further modifications to the Board's order until she has successfully completed one (1) year of compliance with the terms and conditions of the Board's May 14, 2010, order.
