On December 2, 2010, the Board of Nursing considered information in regard to petitioner's failure to comply with the terms and conditions of the Board's order dated May 14, 2010, which granted her a limited license, subject to conditions, for the sole purpose of completing a nurse refresher course. The Board's order required that petitioner submit to random drug testing in an approved drug testing program. Petitioner's selection for actual testing is dependent upon her daily call-ins to the program. The information presented shows that petitioner missed a total of fifty-three call-ins to the program from August 9 through November 27, 2010. Based upon the information presented, the Board finds and makes the following:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the limited license issued to ANNE M. GRAF, R.N., (lic. # 93746-30) for the sole purpose of completing a nurse refresher program is hereby RESCINDED effective immediately.

IT IS FURTHER ORDERED that petitioner shall be required to demonstrate 6 months of compliance with the random drug testing at a frequency of 14 tests per year with one additional hair test prior to petitioning for reissuance of a limited license to complete the nurse refresher course.
