On March 26, 2010, the Wisconsin Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated October 12, 2006, to remove the limitation on her access to controlled substances for patient administration, to reduce her drug screens. Based upon the evidence presented which shows that the petitioner is in compliance with the terms and conditions of the order, the Board now finds and enters the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for access to controlled substances for patient administration in the workplace and a decrease in the drug screens for the petitioner CHRISTINE A. BAYER, R.N., (lic.#127337-30) is hereby GRANTED.

IT IS FURTHER ORDERED that the frequency of the petitioner's drug screens shall be reduced to forty-eight (48) per year, plus one additional hair test.

IT IS FURTHER ORDERD that petitioner's stay shall be continuous and will remain in effect unless the petitioner is determined to be in violation of the Board's Order.
