BACKGROUND

On March 3, 2010, the State of Wisconsin Dentistry Examining Board (Board) considered Dr. Pultz's request to modify the terms of its Final Decision and Order dated January 31, 2007, by reducing his random urine drug and alcohol screens. Previously, on May 5, 2008, the Board had reduced Dr. Pultz's urine drug and alcohol screens from ninety-six to seventy two screens per year. Based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Dr. Robert B. Pultz's request to modify the Board's May 5, 2008 Order by reducing the number of annual random urine drug and alcohol screens that he must submit, be and hereby is Granted.

IT IS ALSO ORDERED, that the number of random urine drug and alcohol screens shall be reduced from seventy-two to twenty-eight screens per year, at least one of which shall be a hair test.

The effective date of this Order is March 3, 2010.
