On January 28, 2010, the Wisconsin Board of Nursing considered the petitioner's request for modification of the Final Decision and Order of the Board dated March 1, 2007, to remove the restriction on his approved workplace and allow him to work public health, home health or hospice setting and reduction in therapy and drug screens. Based upon the information presented which shows that it has been less than one year since the previous modification of the Order, but there is support for the reduction in therapy and screens, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that request of the petitioner MARK KONGSHAUG, R.N., (Lic. # 115710-30) to remove the restriction on his approved work sites is DENIED.

IT IS FURTHER ORDERED that the petitioner's therapy may be reduced in accordance with the recommendation of his therapist and the petitioner's drug screens shall be reduced to fourteen (14) per year, plus one additional hair test. When the petitioner returns to employment as a registered nurse, the drug screens shall be increased to forty-eight (48) per year, plus one additional hair test, in accordance with the Board's testing schedule.
