On October 14, 2010, the Wisconsin Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order dated July 26, 2007, to eliminate work setting restrictions, discontinue her terminate sessions, discontinue or decrease Narcotics Anonymous (NA) meetings attendance and to eliminate or decrease her drug screens. Based upon the information presented, petitioner has not attained sufficient time in compliance under the order and her current prescriptions are not reflected on her drug screens, therefore, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that request for modifications to the limited license of CHERYL A. MILLER, L.P.N., (lic. # 30256-31) is GRANTED in part and DENIED in part.

IT IS FURTHER ORDERED that petitioner's request to discontinue the therapy sessions is GRANTED.

IT IS FURTHER ORDERED that petitioner's request to eliminate her work-setting restrictions is DENIED.

IT IS FURTHER ORDERED that petitioner's request to terminate or reduce her drug screens is DENIED.

IT IS FURTHER ORDERED that petitioner's request to decrease her NA meetings attendance is DENIED. Petitioner's attendance shall be increased to two (2) meetings per week due to the discontinuation of her therapy sessions.

IT IS FURTHER ORDERED that petitioner shall submit an explanation regarding the fact that her current prescription are not reflected on her drug screens and submit to a drug screen via a hair test.
