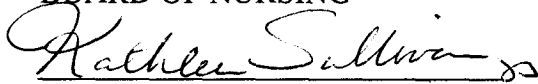
ORDER

IT IS FURTHER ORDERED that an inadvertent scrivener's error in the Board's prior order dated March 1, 2010, stating that petitioner's license had been revoked is hereby CORRECTED. The petitioner's license was indefinitely suspended, and not revoked, pursuant to the Final Decision and Order of the Board dated January 24, 2008.
