ORDER DENYING REQUEST FOR STAY OF SUSPENSION

On November 4, 2010, the petitioner appeared before the Wisconsin Board of Nursing in support of her request for a stay of suspension. The information of record shows that petitioner has not been compliant with the board order dated November 8, 2007, and her stay of suspension was removed on September 9, 2010. The information of record further shows that petitioner has repeatedly missed tests, asked to be excused from testing, and stated to First Lab, the drug testing program, that she was excused by Department staff when she was not. The petitioner's overall level of compliance with the Board order has been troubling and based upon petitioner's demeanor and response to questions during her appearance, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request of the petitioner, PAMELA J. DEVINE, R.N. (lic. # 132348-30) for a stay of suspension is hereby DENIED.

IT IS FURTHER ORDERED that <u>before</u> a future petition for a stay of suspension will be considered by the Board, petitioner shall obtain a psychological evaluation from a board-approved provider, submit a copy to the Department Monitor, and demonstrate (3) months compliance with the terms and conditions of the Board order.
