PROCEDURAL HISTORY

On August 18, 2009, the Wisconsin Chiropractic Examining Board (Board) issued an Order Fixing costs against the Respondent. The Order required the Respondent to pay costs as outlined therein on or before November 7, 2009 unless the Respondent petitioned the Board for, and was granted, a different deadline. On November 2, 2009, the Respondent submitted a petition requesting an extension to pay that was considered by the Board at its November 12, 2009 meeting.

ORDER

IT IS HEREBY ORDERED THAT, Kevin M. Servi is granted a 10 day extension, starting November 19, 2010, to pay the amounts specified in the October 8, 2009 Order Fixing Costs.

IT IS FURTHER ORDERED that Dr. Servi's license will be suspended without notice or hearing, if full payment has not been received by the Department of Regulation and Licensing on or before November 29, 2010. The Board or its designee will remove the suspension if provided with sufficient information that Dr. Servi is in compliance with the Order. All other terms and conditions set forth in prior Board Orders shall remain in full force and effect.

IT IS FURTHER ORDERED THAT this Order is effective on the date of signing.
