On February 25, 2010, the Board of Nursing considered the petitioner's request for modifications pursuant to the Final Decision and Order dated November 8, 2007, to full reinstatement of licensure or in the alternative removal of the restriction on access to narcotics for administration to patients and elimination of urine drug screens. Based upon the information of record showing that petitioner has missed call-ins for the drug testing procedure and has not completed the Board-approved nurse refresher course, the Board now finds and makes the following:

#### <u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of licensure and other modifications to the Board order for THOMAS J. BERTHOLD, R.N., (lic. # 70721-30) is hereby DENIED.

IT IS FURTHER ORDERED that the limited license previously issued to petitioner to complete a Board-approved nurse refresher course shall be valid for a period of six (6) months effective from the date signed below.

IT IS FURTHER ORDERED that the petitioner shall submit an explanation to the Board for his missed call-ins for drug testing.
