On May 6, 2010, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated November 8, 2007, to decrease the frequency of his random drug screens and to terminate the therapy requirements. Based upon the information of record showing that petitioner has not completed one (1) year in compliance with the Order to warrant a decrease in screens, but has support from his health care provider to terminate therapy, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modifications to the Board Order for THOMAS J. BERTHOLD, R.N., (lic. # 70721-30) is hereby DENIED in part.

IT IS FURTHER ORDERED that the frequency of the petitioner's drug screens shall not be decreased.

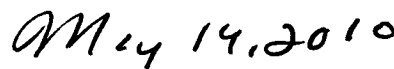
IT IS FURTHER ORDERED that the petitioner's therapy requirements shall be terminated.
