On May 6, 2010, the Board of Nursing considered the petitioner's request for reinstatement of her revoked nursing license pursuant to the Final Decision and Order of the Board dated April 2, 2009. Based upon the information presented which shows that petitioner is compliance with the terms and condition of the Order to warrant reinstatement of licensure, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that a stay of suspension of the limited license of TERRI L. WOLF, R.N. (lic. #100650-30) is GRANTED.

IT IS FURTHER ORDERED that the frequency of the petitioner's random drug screens is hereby modified to forty-eight (48) per year plus one annual hair test in accordance with the Board's current testing schedule.

IT IS FURTHER ORDERED that petitioner shall be required to fulfill the remaining terms of the Board's original order dated December 13, 2007.
