The Dentistry Examining Board considered this matter at its meeting on November 3, 2010.

BACKGROUND

On July 2, 2008, the Board issued a Final Decision and Order adopting the Proposed Final Decision and Order of the Administrative Law Judge who conducted an evidentiary hearing with regard to the alleged misconduct of the Respondent. Such Final Decision and Order included, among others, the revocation of the respondent's dentistry license, license number 5001378-15. The respondent's dentistry license has been revoked since that time.

On or about August 11, 2010, Dr. Kriemelmeyer petitioned the Board to reinstate his license to practice dentistry.

Based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Dr. Kriemelmeyer's petition to reinstate his dentistry license, be and hereby is, Denied.

The Respondent's license will be reinstated, without the need for further petition to the Board, upon satisfactory proof of the following:

- (1) Clearance for reinstatement by the Wisconsin Department of Revenue demonstrating that the Respondent has either satisfied his obligations to the Wisconsin Department

of Revenue or has a payment plan in place satisfactory to the Wisconsin Department of Revenue to make payment towards his liability owed.

- (2) Successful completion of a mock board examination conducted by Marquette University.
