#### PROCEDURAL HISTORY

On February 5, 2008, the Accounting Examining Board (Board) issued a Disciplinary Order against Gary R. Wollack, Diane K. Wollack and Wollack & Wollack, C.P.A.s, S.C. (Respondents, collectively). The Order held the Respondents jointly and severally liable for the payment of costs in the amount of \$4, 250.00, to be paid on or before the expiration of 18 months from the date the Order was signed, to wit: August 5, 2009. On December 3, 2009, The Department of Regulation and Licensing (Department) received a Petition for Extension in Time to Pay Costs. The Board reviewed the Petition, underlying Order and other materials submitted at its March 11, 2010 meeting.

#### FINDINGS OF FACT

- 1. The February 5, 2008 Order provided that all payments and submissions required by the order be mailed or delivered to the Department Monitor, Division of Enforcement, Department of Regulation and Licensing, P.O. Box 8935, Madison, WI 53708-8935.
- 2. At the Board's March 11, 2010 meeting, the Department Monitor, Sharon Henes, reported to the Board that no payments had been received from any of the Respondents.
- 3. The Board's February 5, 2008 Order contains a provision that enables the Board to suspend the Respondents' licenses and certifications (#1-11273, #1-10207 and #3-1135) without further notice or hearing until Respondents have complied with the terms of the Order.
- 4. The Respondents have violated the Order by not paying the costs in the amount of \$4, 250.00 as ordered.

### CONCLUSIONS OF LAW

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stats. s. 454.15 (2) (a).

2. Based upon the report of the Department Monitor, the Board concludes that the Respondents are in violation of the Board's February 5, 2008 Order by failing to pay the costs as ordered.

#### **ORDER**

THEREFORE, IT IS HEREBY ORDERED THAT, the licenses and certifications of Gary R. Wollack, Diane K. Wollack and Wollack & Wollack C.P.A.s. S.C (#1-11273, #1-10207 and #3-1135), are hereby suspended until such time as the Respondents are in full compliance with the February 5, 2008 Order.

This Order takes effect on the day it is signed.
