TO: Bradley J. Schingen, R.C.P., 551 East 10th Street Fond Du Lac, WI 54935

On March 19, 2008, the Medical Examining Board (Board) issued a Final Decision and Order suspending Bradley J. Schingen's license to practice respiratory care, but immediately stayed the suspension subject to compliance with certain requirements. The requirements included individual and/or group therapy sessions, random drug screens, and mandatory AA/NA meetings.

On May 18, 2009, the Board reduced the petitioner's required group therapy sessions to once every other week and his random drug screens from fifty-six (56) time per year to twenty-six (26) times per year. The petitioner seeks a further reduction in his individual and/or group therapy session requirement from once every other week to once per month.

Based upon the information of record which includes a letter from the petitioner's therapist supporting the modification, the Board now finds and orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request to reduce the individual and/or group therapy session requirement from once every other week to once per month of Bradley J. Schingen, R.C.P., (#28-423) be and hereby is, GRANTED.

The effective date of this Order is September 15, 2010.
