#### PROCEDURAL HISTORY

The Wisconsin Accounting Examining Board (Board) accepted Mr. Gaouette's voluntary surrender of his license and certificate to practice as a Certified Public Accountant in the State of Wisconsin, effective March 19, 2008. On February 8, 2010, Mr. Gaouette's petition to reinstate to full licensure was received. The Board reviewed his petition at its March 11, 2010 meeting.

#### FINDINGS OF FACT

Mr. Gaouette is eligible to reapply for Wisconsin certification and licensure as a Certified Public Accountant.

#### CONCLUSIONS OF LAW

The Accounting Examining Board has jurisdiction and authority in this matter pursuant to Wis. Stat., §446.12.

#### **ORDER**

Based upon the Board's review on March 11, 2010, IT IS HEREBY ORDERED THAT, Terry A. Gaouette is hereby restored to full licensure and certification as a Certified Public Accountant.
