ORDER DENYING MODIFICATIONS AND REMOVING STAY OF SUSPENSION

On October 14, 2010, the Board of Nursing considered the petitioner's request for modifications of the Board's Final Decision and Order dated April 3, 2008. Specifically, the petitioner requested reduction in the frequency of his drug screens and lifting of the prohibition against his access to controlled substances in the workplace. The information of record shows that petitioner is currently in violation of the board order due to his failure to participate in an approved testing program for random urine drug screens. Accordingly, the petitioner is not eligible for any modifications of the terms and conditions of his order or for continuation of the stay of suspension, and the Board now finds and orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the stay of suspension of the license of TIMOTHY B. MURPHY (lic. # 133915-30) to practice as a registered nurse in the state of Wisconsin is hereby REMOVED.

IT IS FURTHER ORDERED that Petitioner's license shall revert to SUSPENDED status upon the effective date of this order and he is prohibited from engaging in practice as a registered nurse until such time as the board reinstates the stay of suspension.

IT IS FURTHER ORDERED that petitioner's request for modifications to the board order is DENIED.

IT IS FURTHER ORDERED that petitioner shall have three (3) months compliance with the order prior to his submission of further petitions.

This order is effective five (5) days from the date signed below to accommodate the mailing time for notice of this action.
