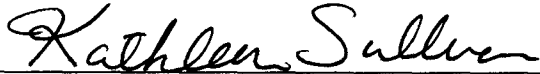
On October 14, 2010, the Board of Nursing considered the petitioner's request for full reinstatement of her registered nurse license pursuant to the Final Decision and Order of the Board dated May 1, 2008. Based upon the information presented which shows that the petitioner has not completed sufficient time under the Board order to warrant full reinstatement, but is eligible for a decrease in the frequency of her drug screens, the Board finds and enters the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the registered nurse license of SHAUNA L. DETTINGER, (lic. # 142093-30) is hereby DENIED.

IT IS FURTHER ORDERED that the petitioner's screens shall be reduced to twenty-eight (28) per year, plus one annual hair test.
