On May 6, 2010, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated June 5, 2008, to decrease the frequency of her random drug screens, terminate her therapy, reinstate her multistate compact license and remove restrictions on her approved work-setting. Based upon the information presented the petitioner has not completed sufficient time in compliance under the Order to warrant approval of all requested modifications, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the request for modifications to decrease drug screens and terminate therapy for ALICE M. WIGER, R.N. (lic. # 151880-30) is GRANTED.

IT IS FURTHER ORDERED that petitioner's screens shall be decreased to twenty-eight (28) per year plus one annual hair test.


IT IS FURTHER ORDERED that petitioner's request for reinstatement of her multi-state compact license and removal of work-setting restrictions is DENIED.
