Based upon information presented to the Board of Nursing on November 5, 2009, which included unexplained positive drug screens, the Board of Nursing suspended Paula Salkin's registered nurse license effective November 15, 2009.

Information submitted in support of Paula Salkin's request for a stay of suspension pursuant to the Board of Nursing Order dated September 4, 2008 was reviewed on April 13, 2010. Documentation shows that Paula Salkin has been in compliance with the terms and conditions of the Board Order and thereby qualifies for a reinstatement of the stay of suspension.
